**Interment Rights**

The following price includes the interment rights, care & maintenance fund contribution, and HST. Each individual grave may accommodate a maximum of three interments in one of the following combinations: 1 casket and 3 cremation urns, 4 cremation urns. Due to soil conditions, extra depth burial is not available. Cremation lots accommodate a maximum of 4 cremation urns.

**Care and Maintenance Fund Contribution**

Graves 24 square feet or larger (adult grave)	The greater of 40% of the lot price and \$250.00
Graves less than 24 square feet (child grave)	The greater of 40% of the lot price and \$150.00

**Interment Fees**

The following prices include digging and backfilling the grave, removal of excess soil, reseeding and fertilizing. HST is not applicable to these prices.

**Payment Terms**

For all At-Need purchases, payment is due in full.

For Pre-Need purchases under \$5,000.00, a deposit of 40% is due at time of purchase, with the balance payable quarterly for 1 year. Interest is not charged on the balance.

For Pre-need purchases over \$5,000.00, a deposit of 40% is due at time of purchase, with the balance payable quarterly for 2 years. Interest is not charged on the balance.

Pre-Need services purchased separately from interment rights are due in full at time of purchase.
